# COMMITTEE REPORTS

ARCHITECTURAL: Jim Powell (467-1209)

Vinyl Siding. There has been much information and misinformation circulated within the community over the use of vinyl/aluminum siding within Lake Christopher. The facts are as follows:

In accordance with the Lake Christopher Homes Association (LCHA) covenants, no change may be made to the exterior of any house including color changes, without the express written authorization of the Architectural Committee.

Last summer, a resident submitted a request for vinyl siding within Lake Christopher. The request was ultimately denied because the yellow color, glossy finish, and width of siding did not conform to the flat finish, earth tone colors and 7 inch planked wood appearance of that section of homes in Lake Christopher.

After being notified that the request had not been approved, the resident commenced installation of vinyl siding in violation of the covenants which specifically state that all changes to the exterior appearance of homes must be approved by the Architectural Committee.

The Board of Directors obtained legal counsel and sought an injunction to stop work on the siding. Prior to being heard by a judge, an agreement was reached between the resident's attorney and the LCHA lawyer that work would cease and only the exposed north wall would be finished. The resident subsequently violated this agreement and completed installation of the siding on the residence.

At the court hearing, the judge ruled in favor of the LCHA after finding that the covenants had been reasonably (and consistently) enforced. He therefore informed the resident that since he knew, before he started work, that his request for vinyl siding had not been approved; that once started he knew LCHA was taking legal action to enforce compliance with the covenants; that the court was left no other alternative but to rule in support of LCHA and direct that the siding be taken down "forthwith".

Follow-up action will be taken as necessary to ensure the court ruling is complied with.

"Why did we take a resident to court?" is a question that I and other Board members have been asked. It is my opinion that the covenants are very specific in the area of exterior changes; any change requires written approval from the Architectural Committee. The involved resident was denied his request, yet chose to go ahead and install siding which was disapproved for color, among other things. I have been asked before what action would be taken if a resident failed to comply with the covenants. My response has been that we would go to court if necessary. This resident chose to test our ability to enforce the covenants. If no action had been taken by the Board, we would have threatened the future enforceability of our covenants. It was, and is, our opinion that the covenants must be followed and restrictions enforced if we are to maintain Lake Christopher as a well-kept neighborhood. It is unfortunate that this resident will incur some financial loss, however it must be remembered that he knew before he replaced his siding that court action was a possibility and once started, he knew legal action was being taken to stop work prior to completion.

The issue of vinyl/aluminum siding within Lake Christopher was discussed at the annual meeting (attended by approximately 120 homeowners). The use of vinyl/aluminum siding, subject to controls by the Architectural Committee, was approved by an approximate vote of 117 to 72. (Note: Three individuals who supported vinyl siding actively sought and obtained over 50 proxy votes.)

This action in no way affected the court action against our resident. It merely reenforced the interim guidelines determined earlier by the Board, i.e. vinyl siding would have to conform to the same color, finish, and width standards as wood siding.

- Sow seeds of peas, spinach, mustard, turnips and radish.

### RESIDENTS TALK

Dear Neighbors:

I would like to bring to your attention something that has made me appreciate the fact that we don't love our animals. Recently two senseless deaths occurred because we don't care enough for our pets to take care of them properly.

I live on Canoe Landing and my back yard abuts the property we all discussed at the homeowners meeting which lies between Captain's Run and Quarry Lane. Our neighbors there have had two sheep which they kept as pets and natural lawn mowers for some time now. These two animals were quiet and clean and to tell the truth, fun to watch as they grazed. They provided a pastoral view out our kitchen window.

One night I was awakened by their bleating, I didn't know what was wrong and I guess in my sleep I assumed that it was the fact that they were cold, for the wind was quite strong. I looked out my window and could not see anything but two vague white shapes. The next morning I looked out the window to see if they had weathered the storm. Both animals were lying down and their coats were soaked with blood. There was a medium size black dog lying near which soon stood up and trotted away. I dressed and paid a call on the owners who had not yet discovered their tragedy. A vet was called, and the sheep were put out of their misery.

The sheep were attacked by a dog. A dog owned by someone who "loved" him so much that he was left out on his own all night. The sheep were not attacked by a hunting instinct, their throats and underbellies were not the focus of destruction. This dog was "playing". They were worried by biting and tearing of the flesh from their rumps and flanks. The wounds took all of the skin and muscle down to the bone.

I have been concerned when my children play in the droppings of our pets at the park across the street - droppings which should not ever be left because of the leash law and the prohibition of pets from these areas. I have been angry when unrestrained dogs chase my paper boy son on his morning rounds. But I am sickened by the wanton carnage which I have observed during this incident and I plead with you who profess to be animal lovers to love your pets and keep them under the control that they need.

(ED. NOTE: According to the Virginia Beach Code, it is unlawful for a dog or cat to roam or run free; call Bureau of Animal Control at 427-5000 for violations and requests for impoundment. No dog shall make an unreasonable amount of noise (Va. Beach Code). Under the Va. Beach defecation law (wherein people are to scoop poop if they permit their dogs o do it on private property) the procedure is for the complaining party to document the offense (picture is a technique) and telephone the 1st precinct magistrate at 427-4724 so a warrant can be issued and the case heard in court. The person witnessing the event is the one who must testify and submit evidence. Taken from TIMBERLINES, June 1984.)
